RAILCAR REPAIR DEPARTMENT

Finger Lakes Railway (FGLK) is currently accepting applications for a Railcar Repairperson- Railcar Inspector. The position is responsible for the inspection, repair and maintenance of the engine and mechanical components on diesel locomotives.

DUTIES INCLUDE:

Must have knowledge of and be familiar with various types of tools and equipment such as, but not limited to, welders, torches, hammers, jacks, and various types of other mechanical, pneumatic, and hand tools. Operating heavy equipment such as construction, farm, etc.

- Ability to interpret instructions furnished in written, oral, diagram form.
- Conduct inspections to identify defects, evidence of wear, and damages to equipment.
- Must be willing to learn and comprehend state and federal regulations as it relates to the railroad industry.
- Must be willing to learn the interchange rules as they pertain to freight cars.
- Learn and perform air tests, inspect, and repair freight cars or components for structural defects and wear according to FRA guidelines.
- Comply with the guidelines set forth by the FRA on Personal Blue Signal Protection of Workers.

REQUIRED SKILLS:

- Must be able to lift heavy objects, (parts tools etc.)
- Must be able to bend, stoop, twist, kneel, squat
- Must be able to work at heights of 18' or more
- Must be able to walk on level or uneven ground for long periods of time
- Must be able to stand for long periods of time
- Will be required to work indoors in a shop environment, and frequently outdoors, regardless of weather conditions
- Mechanical, welding and /or electrical background preferred
- Will be required to work on and around heavy and moving machinery
- Company provides in-house on the job training

MINIMUM QUALIFICATIONS:

- 18 years or older
- Valid Driver's License

Must wear personal protective equipment such as safety glasses, safety vest, safety boots, hard hats, and hearing protection where the company requires.

This is a safety sensitive position. The candidate selected for this position must successfully complete a job demands function test and medical examinations. Employment with FGLK is contingent upon the successful completion background check, a job demands function test and medical examination. The medical examination includes a drug screen and a medical assessment to ensure that candidates can safely perform the essential functions of the job. FGLK will conduct an investigation into newly hired or transferred employees regarding their past employment, state and federal criminal history, military history, driving history, education, professional license or certification verification if job-related, Social Security number, prior drug history, and other job-related information.
